Jim Catterick provided some information about the use of these perfins on similar Canadian revenues.

There are two CTCo'patterns' found on Canadian Customs Duty and Excise stamps 1912-1945. One of these patterns has a T one hole shorter than the other.

The EHF pattern is also found on Canadian Customs Duty stamps 1914-1938.


TRAMWAYS BOARD

The Metropolitan Transit Authority of Victoria has used a perfin that looks like a 'TD' but was supposed to be 'TB' standing for Tramways Board an earlier name of the authority.

Bryan Toop has soved the mystery of the initials. He reports the

pattern illustrated below on a copy of the KGV sideface 1 1/2d red small multi wmk p.13 1/2. This pattern is quite clearly a 'TB'.



At some stage the middle pin was broken or removed. Does anyone have issues of this complete TB pattern with postmarks or early issues of the pattern with the missing pin so that we can date the change?

Commonwealth OS (Type H)

A number of people have reported this pattern on stamps previously unreported. The pattern is that found on Kangaroo, KGV sideface issues and 3 commemorative issues 1913-1929. It was used by all Commonwealth Government Departments and State Government Departments in Western Australia, Victoria, Queensland, South Australia and New South Wales (New South Wales for a brief period only).

Judith Sidaway reports this pattern on a copy of the 1 1/2d Canberra of 1927. The usual OS perfin found on this issue is the 'Melbourne' OS.



Bryan Toop reports this pattern on a copy of the 1/- 1932 Lyrebird. Formerly the only OS perfin suggested to exist was the large OS(s with 12 holes) used by New South Wales in 1933. Even this last pattern had not been confirmed though I understand a copy was on display in one of the Stampshow exhibits.

Ken Moore reports the Commonwealth OS perfin on a South Australian 1d red crown/SA watermark issue, the postmark of which appears to be Adelaide 1902.

In the July 89 issue of the Bulletin a copy of a Tasmanian 2d violet pictorial with this perfin was reported.


Commonwealth OS (Type H) cont.

After the introduction of the large OS perfin on the Kangaroo issues the Commonwealth Printer submitted a'proof' of a smaller OS pattern, the pattern that we are discussing. The proof was submitted on 30th May 1913. The machine/puncturing head would have been in existence prior to this date, but when were they produced? Usage of the pattern supposedly ceased during 1931. While the 1 1/2d Canberra issue falls into the period of usage the 1/-Lyre certainly does not. When was the machine/puncturing head for this pattern destroyed?

There are quite a few possible explanations some of which are given below. I cannot tell which if any are correct at this stage. Does anyone have any more information or ideas?

- 1) All or some of these issues are fakes or forgeries.
- 2) Some of these issues were produced as samples, tests or per favour. Whichever, they were produced on the existing machine/(s) though possibly not between 1913-31.
- 3) The State issues were punctured and issued in 1913or 1914 thereby using up stocks of stamps held after the introduction of the Commonwealth stamps in 1913. One would have to assume that the postmark on the South Australian issue was incorrect or something of the sort.
- 4) The later issues,1 1/2d Canberra and 1/- Lyre, were punctured in late 1932 as part of a batch of stamps for the New South Wales Government. There is some indication that something of the sort had happened. A few years ago a collector mentioned that he had a copy of the KGV 1d green C of A wmk with this perfin. This item has not been checked by me but I have no reason to doubt the report as the collector specialised in KGV issues. Also there is the case of the 2d on 1 1/2d KGV red overprint reported with an OS perfin used by the New South Wales Registrar of Births. Again I cannot confirm the existence of this item.

What do you think? If you have any further strange issues please let us know about them so that we might get an idea of what is happening. Obviously if offered any such issues a bit of caution may be advisable though even a forgery would be interesting in ones collection.

Prices for State Government officials seem to be reaching new heights. A few examples are below.

If you have the money the material is coming onto the market.

WHAT CAN YOU STILL COLLECT ON A LOW BUDGET

With the prices, high by previous standards, being achieved for some of the rare State Government officials it could make one feel that perfins are out of your depth. Certainly we Australians pay much higher prices for official perfins than anybody elsewhere in the world on a regular basis. Why this is the case is a matter of debate. However it does mean that such perfins as above are well out of the range of many collectors budgets, including mine. This does however not mean that perfins are out of range of the collector with low to moderate means.

There are still many areas that can be collected at low cost, with a great amount of challenge.

Foreign perfins (non Australian or NZ)
 Some such are still available for as little as 20c each in Australia.

Most foreign perfins are of course overseas so the situation

in those countries is important. A situation of higher prices in Australia or New Zealand is unlikely to continue for too long as material will in time be brought into the country and increase the supply of perfins available.

United States.

The Perfins Club in the United States has about 800 members of whom about 720 live in North America. The average price of lots in Perfin Club auctions in 1988 was just under US\$2. Material sold in these auctions consisted mainly of scarcer US single stamps and small accumulations of other countries perfins. While prices in the US may have been rising it has been slowly. Much US material is available quite reasonably. If you want to collect foreign particularly US material you could do little better than buying from there also.

If you want to collect officials why not collect US States issues such as those from Iowa, Illinois, Michigan, New Jersey or Hawaii. These perfins in general are quite cheap as most are very common patterns.

Great Britain

Although the Perfins Society is smaller, membership about 250 the auctions form a much more significant aspect of the Clubs activities than in the Perfins Club. Prices over 1988 averaged about £5 per lot. While this may seem higher than the United States situation this is due to the nature of material auctioned. Most of the Perfins Society material are accumulations and include some very large collections often. The highest realisation of 1988 was £205 for a lot of British private perfins,1180 different dies of the letters A-D, total 1450 stamps ie about 13p each.

- 2) Australian State officials
 Why not take up the challenge of postmarks on some of these issues.
 Try to build a collection of FCT postmarks on OS issues. At least you will be sure that you have Commonwealth usage. There must be dozens of postmarks on New South wales State issues, as an example.
 Why not give varieties on OS/NSW 1d reds a go or decimal varieties on VG or G/NSW issues.?
- 3) Australian private types Still an area where you can build up a good collection with a good deal of patience but at moderate cost.

As soon as the Australian guidebook is published the major possible areas of research in private Australian perfins could be on single patterns, die plating and the like , much as has happened in the United States since they had a catalogue available.

The outlook for perfin collecting as a reasonably inexpensive hobby is good at least in my opinion.

PERFIN EXHIBITS AT STAMPSHOW 89

- Exhib. 115, B. Jarrett (4 frames) The Official Mail and Stamps of the State of N.S.W. Award: Large Silver.

 Items of interest included a block of 12 KGV 4 1/2d overprinted 5d with OS/NSW perfin the top row of three double punctured, and a block of 16 1/- Anzac perfinned G/NSW. These were in addition to the other spectacular high value roos etc.
- Exhib. 142, P. Giffen (6 frames) Perfins of British Malaya.

 Award: Large Silver with Felicitations. This was a wonderful exhibit even though my Knowledge in this area is limited.

 Peter's exhibit contained about 40 proving covers including some with censor markings. Items of note were large pieces of MC/P (Municiple Commissioner, Penang)..single line perforator perforating at least 4 at a time and a cover dated March 1909 showing the perfin AG/&Co/LTD (Adamson, Gilfillan & Co. Singapore) with company logo on back.
- Exhib. 318, J. & J. Grant (4 frames) <u>Commercial Perfins of</u>
 <u>Australia.</u> <u>Award:</u> Large Silver with special prize for best Cinderella exhibit. Over 100 proving covers and documents displaying a wide variety of firms.

A few observations.. all exhibits were entered into different classes and all did well. "Philatelic importance" is an area where our exhibit, and probably the other two, fell down in the judging. It will be interesting to see if perfins become more "philatelically important" over the next few years/decades. We have seen four different perfin exhibits now (there was a New Zealand entry at Sydpex) and it would be interesting to see a British perfins exhibit at an Australian Exhibition. There must be collectors who could do this well.

DEMISE OF G/NSW

The New South Wales Government Printing Office was closed in September 1989 and much of their equipment was auctioned in October by Auctioneers Mason, Gray and Strange. As the New South Wales Government Printer used to puncture stamps with the G/NSW pattern it is probably safe to assume that the G/NSW perfin will no longer be used by the few Departments that did so.

The New South Wales Government and its agencies had the longest usage of perfins of any user in Australia and probably the longest user of official perfins worldwide. Usage started in 1895 of the GR perfin used by the Government Railways and continued for 94 years, through a variety of patters to the G/NSW in recent use.


Undoubtedly quite a few million stamps were punctured and used. Any one like to take a guess as to how many?

PRIVATE PERFINS OF NEW SOUTH WALES PART ! : POSTAL ISSUES Update no.1

The original article listing NSW private perfins on postal issues was published in the Australasian Perfins Bulletin July 1988. Additional information has been supplied by quite a few collectors. All of their contributions were much appreciated.

Again we have a couple of perfins applied to New South Wales stamps possibly interstate, TS/F and TCB/&Co. In the case of TS/F 3 copies were reported which does at least indicate it was not an isolated usage.
